Markets remain on guard as U.S. tariffs—especially the 50% rate on Brazil and copper—marshal mixed global sentiment. Yet, resilient tech players like Nvidia (now a \$4 trillion stock) and selected A names (Astera Labs, Rubrik) are sustaining momentum. In emerging markets, Indian large-caps (TCS Voltas, Motherson, JK Tyre) continue to draw positive attention.

Strategy Tip: Focus on core growth sectors (tech, AI, energy) while hedging with economically resilient domestic plays like select Indian large-caps and quality financials.

## Scorpion Capital Special Market View

- US Tariff Impact: Volatility will persist through August 1 tariffs. Past patterns suggest a short-term dip followed by recovery—merit in rotating into AI leadership names post-washout.
- India Outlook: Domestic fundamentals remain intact—TCS result-watch, Nifty near 25,500 support, with volatility playing out as trade news evolves. Monitor RBI commentary for rate direction.
- FX & Commodities: Watch currency movement closely—USD softness tied to tariff fatigue could be offset by safe-haven gold and weakening rupee.
