The IPO surge continues to signal investor confidence — especially domestically driven. Yet valuations will be tested, especially with looming rate and inflation risks. Selectivity is essential: look for listings with strong moats, balance sheets, and defensive underpinnings.

Macro & Policy Backdrop:

The RBI's emphasis on stability, growth, and calibrating trade headwinds is timely. India's macro foundations—domestic demand, fiscal prudence, financial inclusion—are sources of resilience. But global fragmentation and protectionism are nontrivial dangers.
